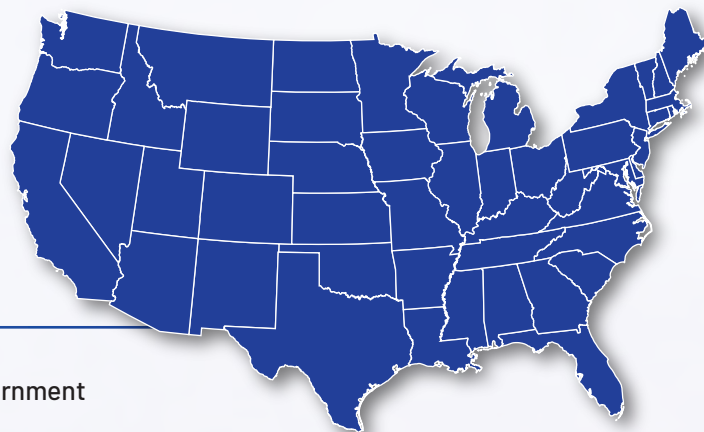

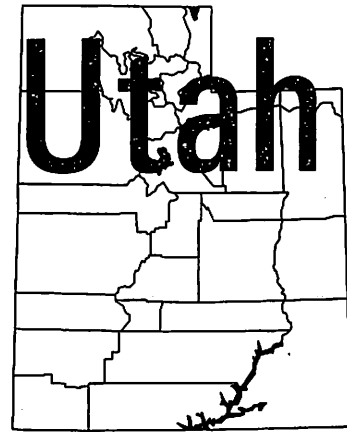

Criminal Records

Access to Records is Restricted.

Employers not identified by state statute cannot request records, even with notarized release from prospective employee. Records are not open to the public nor to employers not identified by statute signature. Sexual Offender Registry

Utah Code § 77-27-21.5 requires the Utah Dept. of Corrections to operate, and maintain a registry of persons who have been convicted of certain sex offenses. The offenses are listed within the subsections.

Indexing & Storage: New records available for inquiry in 60 days after sentencing.

Searching: Direct email questions to registry@utah.gov. Include in request- name, DOB or SSN, requester name address and phone number.

Access by: mail, in person, online.

Mail search: Turnaround time: 20 days. Records are searchable by petitioner submitting name and

phone number, then search by ZIP Code, or by name and an identifier (such as DOB, SSN, etc.)

In person search: They will respond by mail only.

Online search: The Registry may be searched from the Search link at the web page. Records are searchable by name, city or geographic area, county, or ZIP Code. The information released includes photos, descriptions, addresses, vehicles, offenses, and targets. One can also search by specific area please register for email alerts.

Incarceration Records

To request records or compiled data from the Utah Department of Corrections, please send a formal, written request for information to the address above. The agency follows the Utah GRAMA procedure regarding access by the public to records.

Indexing & Storage: Records available on current and former inmates. New records available for inquiry in 1 to 20 days.

Searching: Direct questions to corrections@utah.gov. Include in request- full name and DOB. The SSN and inmate number, date range of record search and type of record are helpful. Requester should include his/her name, address and day phone number. Location, conviction and sentencing information, and release dates are provided. This data not released: SSN, DOB and specific prison housing location.

Access by: mail, online.

Fee & Payment: The agency may charge a \$.25 fee per copy. Fee payee: Utah Department of Corrections Personal checks accepted if amount in excess of \$50.

Mail search: Turnaround time: 10 days. The Agency suggests to the GRAMA request form found at <http://attorneygeneral.utah.gov/cmsdocuments/GRAMARequestForm.pdf>. A SASE is requested.

Online search: An offender search is provided at <http://corrections.utah.gov/index.php/services/offender-search.html>. Search by name or offender number. The site includes information on only current inmates; historical data is not available.

Statewide Court Records

Indexing & Storage: Records available for many district court locations since late 1980's, smaller courts from mid 1990's. Complete data is available for all district court locations since 1998. New records available for inquiry in seconds.

Searching: Include in request- full name, DOB, specific counties or geographic area to search. The SSN is optional. **Online search:** Case information from all Utah District Court and Justice Court locations is available through Xchange. Note that Justice courts oversee Class B and C misdemeanors, infractions and small claims cases. Fees include \$25.00 registration and \$30.00 per month which includes 200 searches. Each additional search is billed at \$.10 per search. Information about XChange and the subscription

agreement is found at www.utcourts.gov/records/. Record access to XChange is considered to be equivalent to an on-site search using public access terminals at the courts. Also, one can search for supreme or appellate opinions from the general website, no fee charged. Locate a specific court by county at www.utcourts.gov/directory/.

Indexing & Storage: Records available for all active and past entities. New records available for inquiry in 5-10 days.

Searching: Include in request- full name of business. In addition to the articles of organization, business entity records available include: Annual Reports, Officers, Directors, DBAs, Prior (merged) names and Reserved names.

Access by: mail, phone, fax, in person, online.

Fee & Payment: Search fee is \$12.00. Certification is \$12.00. Copies are \$.30 per page, no charge if under 10 copies. Fax transmittals are \$5.00 for the first page and \$1.00 each page after. Fee payee: State of Utah. Prepayment required. Personal checks and major credit cards accepted.

Mail search: Turnaround time: 5-10 days. A SASE is requested.

Phone search: Copies cost \$.30 per page. They will answer questions on name availability, status, agent and officer information.

Fax search: Turnaround time is 5-10 days. There is an additional fee of \$5.00 for the first page and \$1.00 for each add'l.

In person search: However, usually turnaround time is 5-10 days unless expedited fee paid.

Online search: A number of search options, including business entity, principle, Certificate of Existence is available at www.utah.gov/services/business.html?type=citizen. Basic information (name, address, agent) is free. Also a subscription service is offered with expanded data. The website also offers an Unclaimed Property search page. Also, search securities professions database free at www.securities.utah.gov/investors/before_verify.html.

Other access: State allows e-mail access for orders of Certification of Existence at orders@utah.gov

Expedited service: Expedited service is available. Turnaround time- 24-48 hours. Add \$75.00 per filing document for expedited research.

Indexing & Storage: Records available from 1965. Records are computerized since 1995. New records available for inquiry in 24 hours or less.

Searching: Use search request form UCC-11 (can be downloaded from web). All tax liens are filed at the county level. Include in request- file number(s) and/or debtor name(s), name and address of requesting party, and daytime phone number. Check out the search instructions page at http://corporations.utah.gov/pdf/ra9_search_instructions.pdf.

Access by: mail, fax, in person, online.

Fee & Payment: Certified search fee is \$12.00 per file number or name certified plus copies are \$.30 per page. For uncertified searches, the fee is only \$.30 per page. There is no fee if under 10 specified copies. Fee payee: State of Utah. Prepayment required. Personal checks accepted. Major credit cards accepted for online system.

Mail search: Turnaround time: 10 working days. A SASE is requested.

Fax search: Same fees and turnaround time as mail search apply. They will invoice.

In person search: Counter service is available.

Online search: Search UCC uncertified records free at <https://secure.utah.gov/uccsearch/uccs>. Search by debtor individual name or organization, or by filing number. Certified searches may also be ordered for \$12.00 per search. To receive certified searches, you may be a registered user or use a credit card. The website gives details. Note for subscribers there is a \$70 annual registration fee which includes 10 user logins. Email requests are accepted at orders@br.state.ut.us.

Other access: The agency has indicated that records are available in bulk from Utah Interactive. Call 801-983-0275.

Expedited service: Expedited service is available for mail and phone searches. Add \$75.00 per name. Turnaround time is 24 hours.

Federal & State Tax Liens

Records not maintained by a state level agency.

All federal tax liens are filed with the County Recorder. They do not perform searches. All state tax liens are filed with Clerk of District Court.

Records are not accessible by the public; access is limited to the owner(s) of the account(s) or by power of attorney. General forms and tax law information can be downloaded from the website.

Indexing & Storage: Records available for 15 years for business records, for 10 years for individual records. New records available for inquiry in 30 days.

Searching: Requester must have written consent. This agency will only confirm that a business is registered and active if a tax permit number is provided. They will provide no other information. Include in request- use of Form TC880 if a specific record is requested.

Access by: mail, in person,.

Fee & Payment: Copies are \$.65 per record. Fee payee: Utah Tax Commission. Prepayment required. Personal checks accepted. No credit cards accepted.

Mail search: Turnaround time: 1 to 2 weeks. SASE not required. Must use the required form.

In person search: Must use the required form. Turnaround time is 24 hours.

Must have a signed release from person of record or immediate family member.

Indexing & Storage: Records available from 1905 on. Index computer files go back to 1978. Indexes are not available to the public. New records available for inquiry in 1-2 weeks.

Searching: At the website you can download an application or order online from the state. The expedited service described below is for faster service via a vendor. Include in request- full name, names of parents, mother's maiden name, date of birth, place of birth, relationship to person of record, reason for information request, and photo ID of requester. Be sure to sign the request and include a daytime phone number. You may phone, fax or email to request an application form. This data not released: medical records.

Access by: mail, fax, in person, online.

Fee & Payment: Search fee is \$18.00 (increases to \$20.00 on July 1, 2014). Add \$8.00 per name for second copies. Fee payee: Vital Records. Prepayment required. Personal checks accepted. Major credit cards accepted.

Mail search: Turnaround time: 2 to 3 weeks. SASE not required.

Fax search: See expedited service.

In person search: Turnaround time 30-40 minutes.

Online search: Orders can be placed online via the agency's Silver system. See <https://silver.health.utah.gov/birthinfo.html>. Fee is \$18.00, certificate is mailed in 7-10 days. Orders can also be placed via a state approved vendor. Go to www.vitalchek.com. Extra fees are involved. See expedited service.

Expedited service: Expedited service is available for mail, phone and fax searches, via www.vitalchek.com. Turnaround time- overnight delivery. Check the vendor web page for fees. Extra fees are incurred for use of credit card, expedited service (\$10.00) and priority shipping if requested.

Certificates can be obtained by an immediate family member or with written permission from the immediate family.

Indexing & Storage: Records available from 1905 on. Index computer files go back since 1978. Indexes are not available to the public. New records available for inquiry in 1-2 weeks.

Searching: At the website you can download an application or order online from the state. The Expedited Service described below is for faster service via a vendor; www.vitalchek.com. Include in request- full name, date of death, place of death,

relationship to person of record, reason for information request. If you do not know the date of death, include last known date alive. You may phone, fax or email to request an application form. Access by: mail, fax, in person, online.

Fee & Payment: Search fee is \$16.00 (increases to \$18.00 on July 1, 2014), add \$8.00 for each additional copy. Fee payee: Vital Records. Prepayment required. Personal checks accepted. Major credit cards accepted.

Mail search: Turnaround time: 2 weeks. SASE not required.

Fax search: See expedited service.

In person search: Turnaround time 30-40 minutes.

Online search: Orders can be placed online via the agency's Silver system. See <https://silver.health.utah.gov/birthinfo.html>. Fee is \$18.00, certificate is mailed is 7-10 days. Orders can also be placed via a state approved vendor. Go to www.vitalchek.com. Extra fees are involved. See expedited service. Certification of marriage occurring in Utah from 1978 to present can be verified by this office. Requests for certified copies of marriage prior to 1978 are issued by the county where the marriage license was obtained.

Indexing & Storage: New records available for inquiry in up to 1 year.

Searching: Records are certification summaries and not copies of the original records. Download an application at the Forms link on the website navigation bar. Mail or bring the application to the Service Window in-person, or you may write a letter. Include in request- date & place of occurrence, groom's name, bride's maiden name. Also photo identification of the requester is required. One may phone, fax or email to request an application form.

Access by: mail, in person, online.

Fee & Payment: Search fee is \$16.00 (increases to \$18.00 on July 1, 2014) for the certification summary. Fee payee: Vital Records. Prepayment required. Personal checks accepted. Major credit cards accepted.

Mail search: Turnaround time: 2-3 weeks.

In person search: Turn in your order form for a certificate before 4:30 p.m., and wait while it is processed. Requests received at the counter after 4:30 p.m. are processed the following day.

Online search: Orders can be placed online via the agency's Silver system. See <https://silver.health.utah.gov/birthinfo.html>. Fee is

\$18.00, certificate is mailed is 7-10 days. Orders can also be placed via a state approved vendor. Go to www.vitalchek.com. Extra fees are involved. See expedited service.

A Certified Abstract of a record for marriage or divorce can be issued from this office if the event occurred between 1978 and 2008. The District Court has divorce certificates that are less than 75 years old.

Indexing & Storage: Records available for 15 years forward. Requests for certified copies of divorce can be issued by the county where the divorce occurred. New records available for inquiry in up to 1 year.

Searching: Records are certification summaries and not copies of the original records. Download an application at the Forms link on the website navigation bar. Mail or bring the application to the Service Window in-person, or you may write a letter. Include in request- date and place of occurrence, date and place of marriage, husband's name, wife's name. Also photo identification of the requester is required. One may phone or fax to request an application form.

Access by: mail, in person, online.

Fee & Payment: \$16.00 is for the certification summary. Fee payee: Vital Records. Prepayment required. Personal checks accepted. Credit cards accepted: Visa, MasterCard, Discover, AmEx.

Mail search: Turnaround time: 2-3 weeks.

In person search: Turn in your order form for a certificate before 4:30 p.m., and wait while it is processed the same day.

Online search: Orders can be placed online via the agency's Silver system. See <https://silver.health.utah.gov/birthinfo.html>. Fee is \$18.00, certificate is mailed is 7-10 days. Orders can also be placed via a state approved vendor. Go to www.vitalchek.com. Extra fees are involved. See expedited service.

Searching Standards for Federal Courts:

District Courts indexed by defendant, plaintiff, and by case number. Bankruptcy Courts usually index by debtor and case number. Most case files created prior to 1999 were maintained in paper format only. Since 2006, all cases are filed electronically. Paper case files may be stored at the courthouse or forwarded to a designated Federal Records Center (see <http://archives.gov/frc>), the timeframe determined by the Court. These case files may be obtained via the Court or directly from the FRC.

Case data may be viewed PACER, the online public access program. An account is required, the fee is \$.10 per page; there is no fee if a usage does not exceed \$15.00 in a quarter. For details about PACER see the Appendix or go to <https://www.pacer.gov> or call 800-676-6856.

The copy fee is \$.50; \$.10 if electronic document is printed from terminal. Certification fee is \$11.00 per document and \$21.00 for exemplification, if available. If a case is still available from the individual federal court, the search fee is \$30.00. If the case is at the Archives, the case can be ordered from the court. The fee to retrieve a paper file is \$64.00 for the first box and \$39.00 ea add'l box. Also, the public can order copies direct online from the National Archives. The Court has appellate jurisdiction to hear first degree and capital felony convictions from the District Court and civil judgments other than domestic cases. The Court of Appeals hears all appeals from the Juvenile and District Courts, except those from the small claims department of a District Court and those mentioned above. Details on the Court Structure

The **District Court** has original jurisdiction for all civil cases, all criminal felonies, certain misdemeanors, domestic relations cases such as divorces, child custody and support, adoption, and probate.

Justice Courts, established by counties and municipalities, deal with class B and C misdemeanors, violations of ordinances, small claims, and infractions committed within their territorial jurisdiction.

Record Searching Facts You Need to Know

Fees and Record Searching Tips

Most District Courts charge \$15.00 per hour to do a name search, but some provide the first 15-20 minutes free. Most courts charge \$.25 for a copy and \$4.00 for certification.

Most courts provide a public access terminal that provides the same data shown on the XChange – see below.

The Salt Lake District Court has an automated information phone line that provides court appearance look-ups, outstanding fine balance look-ups, and judgment/divorce decree lookups. Call 801-238-7830.

Most records filed in the district courts and justice courts are public meaning that anyone who asks can view the record and make a copy of it. Many public records are available on the court's website. Some records are "private," which means that only the parties, their lawyers and a few others can view and copy the record. Less common are "protected" records, which also means that only the parties, their lawyers and a few others can view and copy the record.

Online Access is Statewide

Case information from all Utah District Court locations and all Justice Courts is available online through XChange. The case information from Justice Courts became available recently on this system, thus the data throughout may vary. Fees include a \$25.00 registration fee and \$30.00 per month fee which includes 200 searches. Each additional search is billed at \$.10 per search. The search provides a summary of the docket index; case files and copies are not available.

Effective April, 2012, certain civil court actions non-public. These actions include divorce, separate maintenance, grandparent visitation, temporary separation, adjudication of marriage, civil stalking, guardianship, conservatorship, cohabitant abuse, custody and support (UCCJEA), (UIFSA), and paternity. The case history with minute entries of public hearings; judgments; orders and decrees; and letters of appointment remain public unless made private by judicial order.

Record access to XChange is considered to be equivalent to an on-site search using public access terminals in those courts which provide the terminals.

29 counties, 29 recording offices. The recording officers are the County Recorder for real estate and the Clerk of District Court for state tax liens. Utah is entirely in the Mountain Time Zone (MST).

The Recorder's office main function is to keep the all real property (land) records for the county and provide the county assessor and treasurer's office with information necessary for assessment and taxation. Also filed in the office are such miscellaneous items as workman's and mechanic's liens, water claims, federal tax liens and military discharges.

County Recorders will not perform real estate searches. Real estate record copy fees vary from \$.25 to \$1.00 per page. Certification fee is usually \$5.00 per seal.

Financing statements are filed at the state level except for real estate related collateral which are filed with the Register of Deeds (and at the state level in certain cases). Many filing offices will not perform UCC searches. UCC copy fees vary but is usually \$1.00 per page.

All federal tax liens are filed with the County Recorder. They do not perform searches. All state tax liens are filed with Clerk of District Court, many of which have online access and most all will perform searches.

An excellent statewide search site for real estate records, provided by the Utah County Government, is found at www.utahcounty.gov/LandRecords/Index.asp. Search for many types of records, including recorded documents, property evaluations, by name, property address or parcel. There is also a delinquent tax search. One may also pull document images of recorded documents if the document number is given.
